### **Chief Justice's observations**

#### **Chief Justice's observations**

Congratulations to you all – and to your family and friends who have also contributed to this outstanding achievement.

As you now know eligibility for admission to the legal profession is not easy to attain.

Qualification requires more than mere approved academic performance and demonstrated levels of practical competence. There are important personal and professional qualities

needed as well. High standards of honesty, integrity and discipline are also indispensable qualities for practising law.

Lawyers represent and reinforce the authority of the legal system and respect for the rule of law.

Their professional conduct informs and often determines the level of community confidence in the courts' ability to administer justice fairly and equally.

You will – quite rightly – use your specialised knowledge for personal reward and career advancement, but you have a particular responsibility to uphold the traditions and values of this honourable profession in all respects and at all times.

This includes helping when it is truly needed but cannot be paid for, at least, in financial terms. Commitment to a fair share of pro bono work has its own, non-monetary, benefits. A professional life driven by a sense of public service is preferable to one driven by greed and ambition.

Finally, a word of advice, arrive on time – whether for court, a business meeting or social engagement – it's respectful.
