Mr Dick and Mr Walker, on behalf of the Judges, I express our appreciation to both sides of politics in this State who, during the short period of my tenure, have treated the Court with courtesy and, particularly recently, have resisted



any temptation to let political or populist considerations prevail over the need to respect the Court's integrity and independence. The balance between the executive, the parliament and the judiciary is a delicate one and underpins our democracy. While it may seem expedient in the short-term for one part of the institution to abuse or attack another part, it ultimately has the capacity to damage or diminish the whole institution, which is democratic government. Our discourse has been civil and I have confidence that it will continue to be so.

The Judges appreciate the support of the profession for the Courts and look forward to an excellent relationship with you, Mr Hughes, as President of the Bar. This is your first appearance here. Mr Fitzgerald, sadly, it is your last as President of the Law Society. You will be missed.
