Speech by the Honourable Justice J D Henry, Far Northern Judge, Cairns Courthouse Opening of 2022/2023 Law Year, Monday, 18 July 2022

Good morning ladies and gentlemen.

I acknowledge the Gimuy Walubara Yidinji people, the traditional owners of this land, their elders past, present and emerging, their ancient customs and lore, as I do those of the traditional owners of all lands and waters within the Far North Queensland jurisdiction over which officers of this courthouse exercise their authority. I hope some are watching this ceremony on livestream.

The mace emerged as a weapon, in the mists of ancient history as homo sapiens reinforced their clubs with a heavy head to use for more effective striking. Over the millenia it also came to symbolise power; leaders and institutions would hold ceremonial maces as representing their authority. Such maces had less substantial heads – as this one does – and were often decorated with symbols of the power of the institution and of the societies they served.

Ceremonial maces continue to symbolise the authority of various institutions, including Parliament, the Courts, the military and universities. It was Professor Henrietta Marrie, inspired by her familiarity with the creative design of a university mace, who proposed the idea, clearly embraced, of a Cairns Courthouse mace, styled with the symbols of the Gimuy Walubara Yidinji people and their traditional lands.

So it was that this mace was commissioned, styled so that the Court's ceremonial use of it will be representative not only of the Court's authority but of its ongoing acknowledgement of the traditional owners of the lands and waters over which it presides.

I am honoured to receive the mace on behalf of the judicial officers of this Courthouse. When its stand is completed it will then be placed on continuing display at the judge's bench in courtroom 1 on level 4 – the Supreme Court courtroom and ceremonial court of this building – save for those occasions when it is required elsewhere for other ceremonial events or displays of the Magistrates Court, District Court or Supreme Court in Far North Queensland.

More generally, I thank the Gimuy Walubara Yidinji people for the generosity of spirit with which they have again embraced this annual ceremony of acknowledgement and reflection.
