### Changes to the SSAT

The Social Security (Administration) Act No. 191 of 1999 will operate from March 2000 and make some changes to the procedure of the SSAT.

Importantly, some matters contained in the Bill, which had adopted recommendations made by Dame Guilfoyle in her review of social security appeal processes, were rejected in the Senate. For example, the Bill had proposed restrictive time limits, such that a person aggrieved by a decision was required to appeal to an authorised review officer within 52 weeks of the original decision, and then lodge an appeal to the SSAT within 28 days. The Bill would have enabled a matter to be heard on the papers and would have required the SSAT to refer new information back to the original decision maker, unless satisfied that the applicant had reasonable grounds for not providing the information to the original decision maker.

The Act, as amended by the Senate, contains no time limits for seeking review and there is no requirement for the discretion to refer new information back to the original decision maker to be exercised. The Act does enable matter to be heard on the papers, but only with the consent of the parties to review.

While it was expected that there would be amendments introduced to allow for Centrelink representation at SSAT hearings, this did not occur. The Act does allow for greater flexibility in the constitution of panels, with a maximum of four, but the ability to constitute smaller panels of one, two or three members.

It is still anticipated that the Administrative Review Tribunal will proceed, with legislation to be introduced in the Autumn session, and the current expected commencement date being February 2001.
