Do you have work colleagues who would benefit from a Social Security Reporter subscription?

Regrettably the first issue of the *Social Security Reporter* in 2004 has to report that this publication is suffering a decline in subscription levels that may affect its long-term viability. The publisher is facing the difficult decision of whether to continue to publish this Reporter.

The SSR is published by the Legal Service Bulletin Cooperative Ltd, an independent, not for profit organisation run by a national collective of volunteers, which also publishes the *Alternative Law Journal* and the *Freedom of Information Review*. Subscriptions are the only source of income for the journals. For the moment the *Alternative Law Journal* is subsidising the production costs of the SSR as we attempt to find new subscribers.

Surveys we undertook last year told us the SSR is highly valued by its core group of subscribers and they are very keen to see it continue. Subscribers we talked to found it invaluable in their work because it provides succinct summaries of significant decisions without the need to wade through numerous, often lengthy decisions on the Internet.

The SSR provides a clear, effective and easily accessible way of keeping abreast of important issues and decisions in the social security area.

We would appreciate it if you could bring the Reporter to the attention of colleagues or others you know who work in the social security area, for example lawyers, financial advisers, or student welfare advisers and urge them to consider subscribing to the SSR.

The *Social Security Reporter* gives you comprehensive and current summaries of Administrative Appeals Tribunal and Federal Court social security decisions, and is the only reporter of Social Security Appeals Tribunal decisions. Contributors are academics and practitioners of Social Security and Student Assistance law. The Reporter also provides information about changes to the *Social Security Act*, related Acts, Regulations and departmental guidelines and procedures, along with comment and background information articles on social security law.
