

Hawkesbury district captured

WINDSOR Municipal Council in New South Wales, commissioned a local artist, K.G. Oxley, to produce lithographs of buildings in the Hawkesbury area.

Windsor, situated in the heart of the historic Hawkesbury district, boasts many fine old buildings. The lithograph reproduced here is of a building known locally as the 'Doctor's House'.

The lithographs are a limited edition, and each is signed by the artist. They are sold in a set of four, measure approximately 19cm x 28cm each and cost \$40 plus postage. The set comprises: Macquarie Arms Hotel, Community and Cultural Centre, Thompson Square and the one illustrated.

The artist has also produced other lithographs of the area and these include: St Matthews Church, a street in Richmond, and an old inn in Windsor. These measure approximately 14½cm x 20cm and cost \$2 each plus postage.

The Council has published a book entitled *Historic Hawkesbury* which is full of information and illustrations about this fascinating area. The book costs \$1.

OVER 60 librarians from throughout Australia attended a seminar entitled 'Commercial Automated Circulation Systems in Australian Academic Libraries', held at Footscray Institute of Technology in late November 1979.

The aim of the seminar was to bring together Australian librarians who have installed commercial automated circulation systems, or who are planning systems with commercial potential, to share their experiences with other librarians who may be considering purchasing such a system.

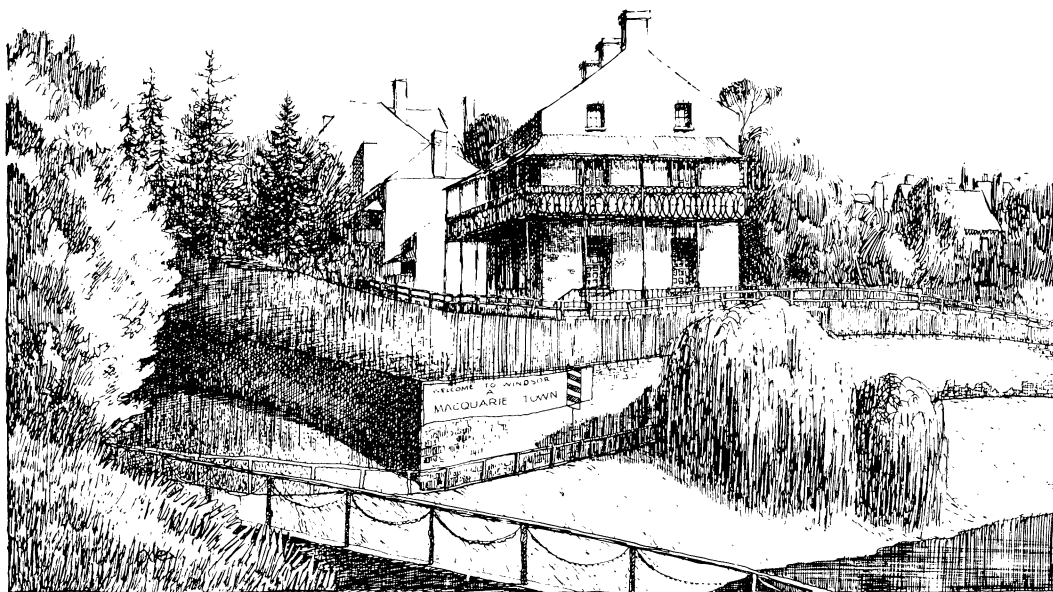
