SEVERAL CHANGES to the Association's staffing took place in 1980. ## **SA TO GO ONLINE**

ENDERS WERE called in early December for an on-line circulation system for the State Library and Public Libraries Divisions in South Australia, Euan Miller the officer responsible for implementation told *Incite*. The timetable is scheduled for a July 81 launch, Mr Miller added.

The libraries were interested in a package that could offer a multi-level circulation function Mr Miller said. As well as controlling the lending functions of the State Library presently rating at 1.5 million issues per annum, the system was expected to control both the PLD circulation of materials to public libraries and in turn, local authority library circulation to borrowers.

It is expected that the PLD will act as a bureau for a selected group of metropolitan public libraries in Adelaide, which will use the system to control their own circulation function. Anticipated excess transaction capacity in the system will allow this, Mr Miller added.

Negotiations are being carried out also, through the Local Government Association of South Australia to establish a co-operative that will allow a much larger group of local authority libraries anticipating automated circulation control to establish a duplicate system that will link in with the SLD/PLD data base.

Other automation options being considered in South Australia at present include automated acquisition and cataloguing control for the Public Libraries Division and the extension of the ABN pilot to a recently established South Australian library network.

The SLD/PLD have combined with the Colleges of Advanced Education and the Department of Further Education to establish the South Australian Network Group (SANG). This group has been charged with the responsibility of investigating the establishment of an on-line regional network and have successfully negotiated with the Barr Smith Library, access to the ABN pilot.
