## 1982 Annual General Meeting

The 1982 Annual General Meeting of the Library Association of Australia was held at 2.30pm on Wednesday, 25 August in the Festival Theatre, Adelaide. Approximately 450 members were in attendance. A number of overseas delegates representing their own library associations were also present – Margaret Obi, Papua New Guinea Library Association; Dorothea Brown, New Zealand Library Association; Mastini Prakoso. Indonesian Library Association and Peggy Hochstadt, Singapore Library Association. All sent their greetings and best wishes to the Library Association of Australia.

James Dwyer, presently Past President of the Association, was presented with a Fellowship of the Library Association of Australia. A Fellowship is conferred on a member who is considered by General Council to have reached an exceptionally high standard of proficiency in Librarianship.

The 1981 Annual Report was adopted by the AGM, as was the 1981 Statement of Income and Expenditure and Balance Sheet. The President outlined the activities of the LAA in 1982. Coopers and Lybrand were appointed auditors for the Association until the 1983 AGM. Two notices of motion were received before the meeting and the President accepted another as being within the scope of the meeting as well as an urgency motion.

The first motion put forward by the Special Libraries Section was: 'The membership fees of the LAA should be substantially reduced.'

The motion was lost following interesting debate on the subject.

The AGM passed the motion 'That a celebration for the 50th birthday of the LAA be held in Canberra in 1987'.

The third motion moved from the floor was 'That General Council be directed to appoint a working party representative of all LAA parts to examine the organisational structure of the LAA. Further, that a report Mr Jannes Dwyer, Past President of the LAA, receives from Judith Baskin, President, a Fellowship of the Library Association of Australia

of this working party be presented to General Council in 1983'. The motion was lost following considerable debate.

An urgency motion 'That this meeting deplores the threat to the National Library of Papua New Guinea and directs the Executive to take appropriate urgent action to bring our concern to the attention of the Government of Papua New Guinea' was passed by the meeting.

The meeting closed at 4.30pm.
