### Australian IBBY Conference

There is to be a conference on children's literature, organised by IBBY.

The conference will be held at the University of Sydney from 25-27 August and a committee, consisting of people concerned with many aspects of education, children's literature and the media, is already well under way with arrangements regarding speakers and so on.

The main theme of the conference will be the electronic explosion and its effects on children's writing, illustrating, storytelling and publishing.

### Public library automation

Graeme Deutscher, President of the New South Wales Public Libraries Automation Group, has announced the appointment of Information Sciences of Australia as consultants to undertake a \$30,000 study into public library automation in New South Wales. Gordon Undy is the consultant assigned to the study and he will commence investigations early in April with a final report due in October, 1983.

The NSW Public Libraries Automation Group intends that the study will provide an overview of current developments in public library automation, an identification of trends, and proposals and guidelines for future development. The study has been designed to give both immediate and long-term benefits to public librarians planning or involved in library automation.

### New Tasmanian appointment

Ray Bartle has been appointed the State Library of Tasmania's Assistant State Librarian replacing Gordon Griffin who retired last year.

Mr Bartle started working in libraries in 1960, in UK county library systems, involved mainly with school and children's libraries until 1971, when he joined the State Library of Tasmania as State Children's Librarian.

In 1974 he was appointed to the then new position of Resources Librarian, responsible for the State Library's resources selection programmes and collection development. He became Research and Development Librarian in March 1982 following administrative re-structuring of the State Library.

Ray Bartle's responsibilities as Assistant State Librarian include general policy and implementation planning, support services for the Tasmanian Library Board and sections involved with staff development, systems planning and publicity. He recently completed a Masters course in Social Science (Admin) at the University of Tasmania.

### Three international 'firsts' for Australian IBBY

Ena Noel has been elected to the International Executive Committee for the period 1983-85.

She will be a judge for the 1983 International BIB (Biennale d'illustrations de Bratislava).

Maurice Saxby has been elected to the judging panel of the 1984 IBBY International Hans Christian Andersen Award.
