'he National Co-ordinating Committee of the Commonwealth Assistance for Public Libaries Campaign (CAPL) has been busy argung the case for Federal Government funding or multicultural public library services on wo fronts.

) Submission on Federal Government Fundng for Multicultural Public Library Services. As readers of InCite will have noticed, a sumnary of the main arguments for Commonvealth Government assistance for multiultural public library services appeared as an asert in InCite dated April 4, 1986.

The full submission, outlining the case in reater detail, has now been finalised and has een submitted to the Jupp Committee which vas established by the Federal Government to eview multicultural programs and services. Copies of the full submission and extra copies of the summary are available from Head Office in request.

The National Co-ordinating Committee vishes to publicise the submission and seeks he help of all LAA members in this. It has also seen suggested that State Campaign Co-ordinators organise public meetings in capital ities to explain the progress of the campaign and to publicise the arguments contained in the submission. It is hoped that these meetings will take place within the next two-three nonths.

) The National Language Policy Report

n February, Derek Whitehead from the lational Co-ordinating Committee took part in delegation organised by the Federation of lthnic Communities Councils of Australia FECCA) which spoke to a number of Federal lembers of Parliament about the delay in imlementing the recommendations of the leport on a National Language Policy which was prepared by the Senate Standing Commitee on Education and the Arts in 1984.

This report recommends:

Recommendation 107: The Commonwealth dovernment should consider providing aditional funds to public libraries to increase heir holdings of materials and services for inority linguistic groups, providing that the tate Governments maintain their current fforts in this area.

'ecommendation 108: State and Public librares and the State Government bodies responible for adult migrant education should iscuss the provision of materials and services or learners of English as a second language, with a view to determining and providing, dequate library services.

recommendation 109: The Commonwealth overnment and State Governments should stablish a comprehensive national program of brary services for persons with communication handicaps.

leccommendation 110: State library bodies and ublic libraries should adopt the recommenations of the Standards for Multicultural bublic Library Service concerning staff evelopment and training.

decommendation 111: Library authorities in ll States and Territories should make provision for regular consultation with ethnic, boriginal and handicapped groups.

The LAA is very concerned that the *Report* n a National Language Policy was produced ome 16 months ago but that no action has yet een taken by the Federal Government. The APL committee has written to the Minister or Education, Senator Ryan, expressing contern at the delay in implementing the report

and would like to encourage members of the Association to write to their local Federal Member of Parliament about the issue.

- WRITE TO: Your local federal Member of Parliament (Names and addresses can be obtained from LAA Head Office)
- HOW TO WRITE: Send either a hand-written letter or a typed letter, either from yourself personally or from your library or council. It will be best if the letters are expressed in your own words.
- WHAT TO WRITE: Some suggestions are given below on what to write:

What is being done?

The report was printed in December 1984. When will the Government implement its recommendations? When will it announce its response?

National Consultative Council

The report recommends setting up a National Consultative Council (recommendation 2) on language in Australia. (If such a body is established, the Federation of Ethnic Communities Councils of Australia would like it to include an LAA/AACOBS representative.) What is the attitude of the Government/Opposition to this recommendation? Does the Government plan to set up the Council? The FECCA delegation regarded the Council as the essential first step.

Funding for libraries

The Senate Committee recommended federal financial assistance to public libraries. When will this be implemented? Express support for its implementation.

Consultation

Senator Ryan said in the Senate on February 24, 1986 that the Government planned to consult widely in preparing its response regarding the proposed National Language Policy. When will these consultations start? Who will be consulted? Will libraries be consulted, and if so, how?

Support

Does the local Member of Parliament support the recommendations of the national language policy report? (This information is very useful for campaigns in support of the policy.)

• REASONS FOR WRITING: Writing to your local MHR (or Senator) means that we will find out what Members of Parliament think, and whether they are committed to the national language policy.

More important, it means that they will ask the Minister responsible for the National Language Policy, Senator Susan Ryan, to answer your questions. The more letters and questions she receives, the more she will be aware of community feeling on the matter.
