More than 500 municipal library staff memors attended a stop work meeting at Richard Town Hall to discuss the Library chnicians case and to hear about the process of a pay claim for Librarians and Chief brarians which is currently before the Comssion. Other meetings were held in a numof of regional centres throughout Victoria.

The LAA has tten to the Secretary of the MAV and to all incils in Victoria seeking to have the MAV's beal withdrawn.

everal resolutions were overwhelmingly lorsed by the meetings:

That this meeting of MOA members condemns the MAV for its intransigent attitude to the public library industry by opposing the MOA's salary claim for Librarians, Chief Librarians and Regional Librarians and its appeal against the Commission's decision to insert the library technician classification into the Award.

That this meeting further resolves to bring these matters to the MAV's attention by marching on the MAV's office immediately following this meeting.

That this meeting further resolves to purue the campaign in support of Library Technicians, Chief Librarians and Regional Librarians by engaging in the Collowing action:

- embark on an immediate campaign of rolling stoppages,
- advise library users to contact their Ward Councillors and Mayor seeking the reasons for the current library dispute and urging the library users to express their

Libraries were again closed on Saturday 31 May as part of a continuing campaign of industrial action.

## Councils' response


The LAA has received replies from another 10 Victorian councils to its letter of 8 May requesting councils' assistance in having the MAV withdraw its appeal against the new classifications for Library Technicians.

The councils of the City of Oakleigh, City of Malvern and City of Dandenong have passed resolutions urging the MAV to withdraw its appeal and the Council of the City of Moe has written to the MAV asking it to finalise the matter as soon as possible. The Councils of the City of Broadmeadows and City of Williamstown have written to the MAV seeking further information about the matter.

Acknowledgements have been received from the Councils of the City of Ararat and the City of Marong.

The Councils of the City of Berwick and the City of Castlemaine have resolved to leave the matter in the hands of the MAV.
