#### **VALA Award deadline** extended

The closing date for applications for the 1986 VALA Award has been extended to 31 October 1986. The award is to be made by VALA (the Victorian Association for Library Automation) to the library or information centre which has, in the opinion of the judging panel, made the most innovative use of currently available technology to improve the service offered to its users. All libraries and information centres in Australia are eligible for nomination for the

Systems nominated for consideration must have been implemented in the period from 1 January 1985 to 30 June 1986, and must have completed a minimum of 3 months operation under normal conditions during that time.

Although the winning system need not be computer based, it must demonstrate a significant commitment to the use of automation to conserve, supplement and/or extend the capabilities of the organisation and its resources, human and financial. Nor will the winning system necessarily be developed totally inhouse. If based on a commercially available package, however it will involve a major adaptation or application of the standard package.

#### Nominations

Nominations must be made by staff of libraries or information centres, or by other interested persons, or by members of the judging panel. In all cases, the written consent of the chief executive officer of the nominated organisation must be obtained before the nomination is submitted.

Nominations should be supported by a clearly typed statement of not more than five A4 pages, double spaced, single sided. The statement should outline:

- (a) The chief function of the nominated system.
- (b) the major hardware and software used by the system.
- (c) Features which, in the opinion of the nominator(s), would make the system eligible for the award.
- (d) The date on which the system was commissioned, and the length of time for which it has been operating.
