ANNIVERSARY CELEBRATIONS

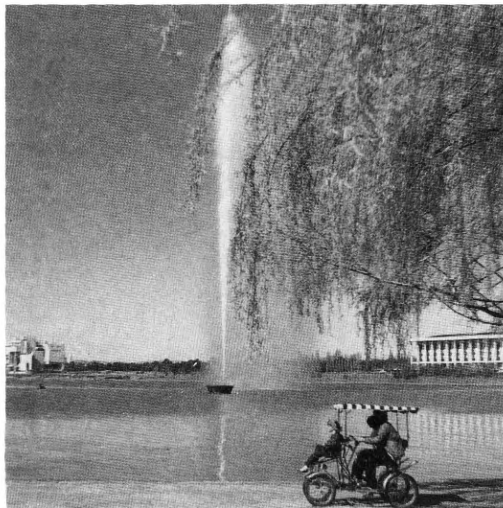

MAKING THE MOST OF YOUR MICRO

On 27 September, 1986, a seminar was held by the Reference and Readers Advisers Group of the NSW Branch of the Public Libraries Section of the LAA. It aimed to illustrate a range of uses to which microcomputers may be put. The seminar followed the state government grant of IBM JX microcomputers to each public library service in NSW.

The group was able to subsidise travelling expenses for librarians from country libraries and some twenty librarians took advantage of this. This seminar was booked out in less than a week, illustrating the high level of interest in the topic.

Speakers included John Wright (State Library of NSW), Stephen Hocking (IBM), Sue Ping Kee (Idaps Aust), Graeme Blewett (Hurstville Library), Lyn Beauregard (Woollahra Council), Sue Boaden (Australia Council), Graeme Patingale and Joan Suckling (Penrith Library).

John Wright outlined practical uses of micros such as bulletin boards, off-line formatting, data base searching and book ordering. He indicated the types of software packages he felt suitable for libraries and suggested group decision making and purchasing software.

Stephen Hocking described the features of the JX and the options available to expand its capabilities. Sue Ping Kee spoke about the Lynx database, its library and trade holdings and its method of searching.

Graeme Blewett described how he went about setting up a local history database, pointing out the unique cataloguing and authority problems of local history items. Lyn Beauregard's area was community information, particularly the benefits of a micro-computer in the provision of community information for the Eastern Suburbs Information Network.

Sue Boaden described the problems of keeping control of newspaper clippings and the development of ARTSDOC, now available on AUSINET. Joan Suckling and Graeme Patingale related the Penrith Library experience of using microcomputers. They illustrated the use of graphics and word processing packages for generating posters, publications and signs. Using FACTFINDERS, a free text database, Penrith are currently producing a ready reference database which includes local history information and findings lists.

AGIS, the Federal Attorney-General's Information Service, contains summaries of the large number of articles reviewed by the Department. Australian, New Zealand and South Pacific periodicals are covered.

The CORPORATE LAW INDEX, provided by Ken Hale and Jim Jackson of the University of Wollongong, is a ready reference to all Australian corporate law cases reported since 1961. Australian and overseas journal articles are also summarised.

Comments, notes and articles on Acts and cases from Australian and overseas jurisdictions are indexed in MONASH FINDER, a database provided by Monash University Law Library.

These indexes complement the full text case and legislation databases and are only three of a number of finding lists available on CLIRS.
