

FLA/LAA 1988 Conference Sponsorship

Sponsoring this prestigious event in Australia will give our organisation the opportunity to develop and consolidate links between Australia, Asia/Pacific and our international network'. So said Mr Colin Harrison (Managing Director of the John Menzies Library Network) when he announced the \$30,000 sponsorship at the Collaroy offices of James Bennett Library Services during his recent visit to Australia. The Network, incorporating James Bennett Library Services, John Menzies Library Services, Coutts, and Readmore, is the first major sponsor of the 1988 IFLA/LAA Conference.

LAA President Mr Peter Dawe commented on the importance of this sponsorship — 'Staging the conference in Australia is the biggest venture undertaken by the Associa-

tion. Without the John Menzies Network sponsorship it is likely that the conference program would have been cut back and the quality of the conference would have suffered'.

Further sponsorship is being sought in a drive headed by Mr Hans Groenewegen and negotiations are underway with potential sponsors. The Association has developed a package of sponsor benefits and is willing to negotiate special benefits for each sponsor

For example, *InCite* will cover the functions and operations of John Menzies, James Bennetts, Coutts and Readmore in the months leading up to the conference. This special benefit was offered because The Network was first to sign as sponsors of the conference.

Preservation Seminar and Workshop

The Management and Policy Studies Centre, Canberra CAE, in conjunction with the LAA, will be conducting a one-day seminar on Library Preservation and Management on 30 November, and a four-day workshop on the Preservation of Library Materials from 1-4 December.

The seminar introduces librarians to the essential components of a library preservation program. All aspects of library preservation will be outlined and methods of formulating and implementing programs will be discussed.

The workshop will cover cleaning, encapsulation, mounting, framing, storage and display, and basic repairs, and will include practical sessions and a field trip to the National Library. It will utilise teaching laboratories, a photographic studio and dark room, X-ray room workshops, information resource centre and an extensive library collection.

It is essential for workshop participants to have either attended the one day introductory seminar or an equivalent course. The cost of attending the one-day seminar is \$125 LAA members, \$165 non-members. The four-day workshop costs \$500 LAA members, \$660 non-members. The venue is the MAPS Centre, Canberra CAE.

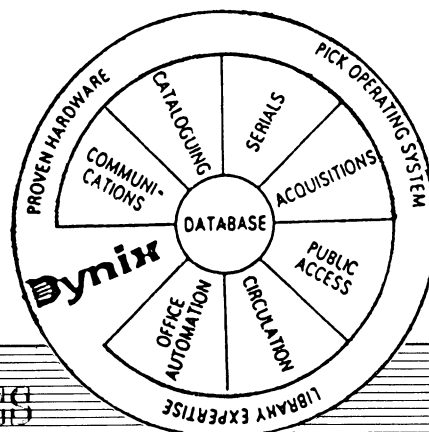
