Building for the future - Canberra building to proceed

At its meeting on 25 November 1988 the General Council of the Library Association of Australia resolved that the Association should construct a national headquarters building in Canberra. It will be built in the area of West Deakin ACT, adjacent to the Royal Mint, reserved by the Australian Government at a low cost for the many national associations now seeking to relocate their national secretariats to the capital.

In resolving thus, Council has considered the short, medium and long term implications of this major development for the Association. It has sought advice from its auditors, property agencies and finance agencies. The advice is that the development is a unique opportunity; that it presents no risk to the viability of the Association; that the subleasing prospects are excellent; that building costs will be favourable; and that the building will provide a long term source of revenue for the Association which is likely to be second only to membership fees.

Council has accepted, on behalf of members, that to fund the best option of constructing and then subleasing 50 percent of the largest building which may be constructed on the site, it may be necessary to sell the Association's current headquarters building in Ultimo. Some constraints in Association initiatives and operations may also be necessary in the short term.


In requesting the goodwill of all members for its decision, Council recognises that the about the relocation of Association's head office to the national capital is longstanding and has occupied much time and energy. Council recognises that there will be reservations about the construction of the Canberra building and the relocation of the Association's head office to Canberra. It also recognises that the Canberra development will affect valued employees of the Association. However General Council, as the elected decision making body of the Association, considers that the overall interests and the future of Association, and of library information services in Australia, must now take priority over those factors. perceived need is for the Association to position itself politically, financially and operationally to help achieve maximum awareness of library and information services as a dynamic and essential part of Australia's future.

Council believes that the congruity of the forthcoming change of the Association's name to the Australian Library and Information Association; its new objects; the development of its major presence in the national capital; the development of local presences initially in Perth, Melbourne and Sydney; and the development of the Information For The Nation campaign, will assert the Association's determination to further increase its growing membership base; and its capacity to assist in underwriting the development and recognition of library and information services in Australia's future.

Site works for the release which includes the Association's land have commenced. A full architect's brief is being developed. Construction will commence early in February 1989 and on completion will be worth \$4.1 million.

A Canberra Building Project Team has been established, and a Project Manager is being selected. Council acknowledged the major contribution Ian McCallum, in association with the Executive Director Sue Kosse, has made already to the project. Mr Philip Cox, the renowned Sydney architect has accepted the commission.

The major considerations in the design selection were:

- a building of lasting architectural quality. It is anticipated that it will meet the Association's needs for fifty years
- a building on which the Association would wish to have a valuation of its role, and that of library and information services, placed
- a building that will be practical; provide an improved working environment for staff; and return maximum revenue because of its attractiveness to lessess.

Council appreciates that members have already indicated they wish to contribute funds directly to this exciting project. Proposals to facilitate this to the best advantage of both members and the Association are being evaluated. Outcomes will be advised to members early in 1989.
