At work and play

'At work and play' will run at the State Library of New South Wales, Macquarie Street, Sydney, from 15 August until January 1990. The exhibition is a pre-World War II photo record of New South Wales.

More than two hundred exhibits — including visuals, historic and rare photographs and research and archival material — will depict people (mainly country people) 'as they were', going about their daily lives.

Photographic records of Australia before 1939 are not plentiful. For this reason, during 1988, as part of a bicentennial project, the State Library sent its photographic expert and support staff to twenty-two New South Wales country towns to discover, reproduce and catalogue historically significant photographs of these years.

One hundred and fifty selected photographs — together with supporting memorabilia — form the focus of the new State Library exhibition, which is expected to draw considerable interest from across Australia.
