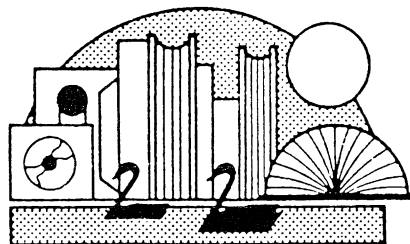

## A.L.I.A 1990

At last count we had received from individual members and Sections of the Association, 80 suggestions for topics and almost 100 for speakers. Some patterns have emerged. The most frequently suggested topics for discussion are:

- funding and resource allocation
- the role of the library and information professional

- computer networks
- industrial relations, quality of working life, job design, etc.

## Conditions for Associateship

**AT ITS FEBRUARY MEETING,** the Board of Education discussed a report prepared by the former Assistant Executive Director concerning the first year of operation of the Association's revised conditions for admission to Associateship.

Fifteen applications were considered by the Board in the twelve months since the revised conditions for admission to Associateship were introduced in late 1987. Eleven of these were successful and four unsuccessful. Ten of the eleven successful applicants held overseas qualifications in library and information science.

Of the three unsuccessful applicants, two held formal tertiary qualifications in library and information science gained overseas, one held a short overseas qualification and one held an Australian postgraduate award in ancient documents. None had sufficient coverage of the core areas in library and information science or broad professional competence and understanding.
