### Election of Vice-President 1993 (President-elect 1994)

#### *Call for nominations*

In 1986, the General Council of the then Library Association of Australia resolved to change the composition of the Executive Committee from President, Immediate Past President, Vice-President, General Secretary, General Treasurer and Chairman of the Board of Education to President, Immediate Past-President, Vice-President and two members of the Council elected by the General Council to the Executive Committee.

The positions of General Treasurer and General Secretary are thus being abolished. This will be completed when revised By-laws are approved by the Governor General. In the interim, these positions are being filled by the two members of Council elected to the Executive Committee.

In accordance with Division F Regulations, nominations are now called for the position of Vice-President 1993 (President-elect 1994). Nominees must be personal financial members of the Association. Candidates and nominations should read the relevant regulations carefully. Please note that nominations must be:

- in writing;
- signed by two personal financial members of the Association;
- countersigned by the nominee;
- accompanied by a current curriculum vitae (giving full details of academic and professional qualifications) and a statement of professional concerns. The curriculum vitae should be arranged under the headings of Present Position, Previous Positions and Professional Activities. The curriculum vitae and the statement of concerns should each not be more than 100 words.

Nominations close at 5pm on 1 September 1992 and should be sent to the Executive Director, Australian Library and Information Association, PO Box E441, Queen Victoria Terrace, ACT 2600.
