

Landmark agreement in library cooperation

Transfer of five major collections from National to La Trobe

LA TROBE University and the National Library of Australia signed a landmark agreement on 10 December, 1991 which will see the transfer on long-term loan, of five major collections of Latin American material totalling 14 000 volumes from the National Library to La Trobe University Library. The two institutions view this agreement as a clear statement of their endorsement of the concept of the Distributed National Collection.

Under the terms of the agreement, La Trobe University Library, which is a recognised centre of excellence in Latin American Collections, will maintain these collections and make them available to scholars through the existing inter-library cooperative arrangements. A measure of the enthusiasm and commitment that La Trobe University has for the ideal of the distributed national collection is its

undertaking to develop these collections through new acquisitions in these subject areas.

The five transferred collections cover a diverse range of topics, and consist of works in many languages, with Spanish and Portuguese being predominant.

Works range in date from early nineteenth century Imprints to the 1960s.

The largest of the collections is the Gulmares Collection which covers Brazilian history and literature.

The Paraguayan Collection comprises historical works on Argentina and Uruguay as

well as Paraguay. The Lopez Collection deals with the history of Mexico. The Mendel Collection and the LACAP Collection consist of works on Latin American politics, economics, literature and history. □

Curriculum Corporation brings in SEARCH

Educators and school librarians will benefit from this new service

SEARCH is a new service for libraries that need current information but also need to consider the cost.

The SEARCH Service is a cost-effective way to access information from the Curriculum Corporation national database without the need to have a computer and modem and without the time-waste of hunting through microfiches. The service provides bibliographic data and in many cases also abstracts and reviews.

Presentation is by curriculum area, and the information includes title, author, date of publication, publisher and ISBN. The SEARCH user can request

items from the Curriculum Corporation national databases: Schools Cataloguing Information Service (SCIS), Curriculum Information Network (CIN), Asian Studies, Environmental Education, Australian Studies, Aboriginal and Torres Strait Islands resources and Computer Software review. The result is sent to the user in a professional print format.

The service enables Teacher Librarians and Librarians to buy resources by selecting from the list, rather than being restricted to material normally available from suppliers. Often the information includes a review of the resource and how other educators may have used it.

SEARCH has a 24-hour message bank on 008 809 678 outside Melbourne, or on 639 1405 within Melbourne. This allows users to phone a query through to the service at any time. It is also available by fax on (03) 639 1616. A SEARCH proforma is also available from the Curriculum Corporation. The service offers a 48-hour turnaround, or if no result is achieved then Curriculum Corporation will contact the user to request an alternative search term.

The SEARCH service is available for only \$8.00 plus 20¢ per title listed, and this includes abstract and/or review details. □
