

Conference sponsorship

We are delighted to announce some very practical sponsorship recently announced by our library suppliers.

Swets has announced sponsorship of \$2 000 to assist two indigenous Australian library workers to attend the Joint NZLIA/ALIA conference in Wellington. This sponsorship adds to the generous personal sponsorship received from one of our members and the amount that is being raised in New Zealand by the Maori Library Workers Network so that there will be a high profile for Aboriginal and Torres Strait Islanders at our conference.

Election of three members by the membership of the Association.

Call for nominations

There shall be a Board of Education as follows:

- ten members, seven of whom shall be elected by the members of the Association and three shall be elected by the General Council;
- at least seven members of the Board must be professional members;
- the President of the Association *ex officio*;
- the Executive Director as a non-voting executive member.

There shall be a minimum 3 practitioners and 3 educators on the Board; practitioners shall be defined as persons working in the field of libraries or information services and educators as persons teaching library or information science.

Terms of office of three members of the Board end on 31 December 1994. Three members are now to be elected by the membership of the Association to hold office from 1 January 1995 to 31 December 1997.

Nominations are hereby called for three positions. Nominees must be individual financial members of the Association at the time of nomination, however they need not be professional members.

Nominations must:

- be in writing;
- be signed by two financial members of the Association;
- include the consent in writing of the nominee;
- be accompanied by a curriculum vitae (giving full details of academic and professional qualifications) and a statement of concerns. The curriculum vitae should be arranged under the headings of Present Position, Previous Positions and Professional Activities. The curriculum vitae and the statement of concerns should each not be more than 100 words.

Nominations close at 5pm on 1 September 1994 and should be sent to the Executive Director, Australian Library and Information Association, PO Box E441, Queen Victoria Terrace, ACT 2600.

Board members retiring on 31 December 1994 are Christine Goodacre, Margaret Findlay and Angela Bridgland. Christine Goodacre and Margaret Findlay are eligible for re-election.
