## Nominations called for VicLIS Forum Branch Councillors

As per the amendment to the *Procedural guidelines*, the VicLIS Forum now has 5 (five) vacant positions for Branch Councillors.

Clause 6 of the *Procedural guidelines* states:

6.1 The Branch shall have the following office bearers:

- i President (1999 — Sue McKnight)
- ii Vice-president, who shall be the President Elect (Erica Maxwell)
- iii Immediate past president (Margie Anderson)
- iv Secretary, who shall be responsible for the administrative affairs of the Branch (Chris Wade)
- v Treasurer, who shall be responsible for the financial affairs of the Branch (Jane King)
- vi Training and development officer, who shall be responsible for the Branch program of activities (Marg Smith)
- vii Branch Councillors, of not less than

three but not more than ten, with at least two positions to be nominated by institutional members. (Aranka Folino; Susan Bray; Edward Lim; Jenny Eddy; Don Schauder: plus five more to be elected now)

The General Councillor, (Trevor Wakely) who shall represent the Branch on Association General Council shall be ex-officio and may or may not be one of the other office bearers.

Nominations are hereby called for the 5 (five) vacant positions (of which up to two candidates may be nominated by institutional members).
