In a special ceremony at ALIA House in October 1999, in honour of his long-standing support of and involvement with the Association, retired National Library of Australia director-general Warren Horton was awarded the special status of ALIA Member 000001.

Warren was most appreciative of the gesture, and remarked, 'The Association has been a most important part of my life from the day I joined the then Public Library of New South Wales staff in March 1957.'

'Participation in its affairs has enriched both my personal and professional lives, and given me far more than I have been able to give the Association in return.'

## Election of ALIA Board of Directors

### Call for nominations

Nominations are called for five positions on the Board of Directors of ALIA as incorporated under *Corporations Law*.

Two directors are to be elected by the membership at large. One director is to be elected by institutional members. Two directors are to be elected by the nominated divisional representatives to the National Policy Congress.

Nominees should be personal members of the Association and will represent the interests of the organisation as a whole rather than those of a particular constituency.

The term of office of directors elected in the first election shall be as determined by the Board of Directors but shall not exceed two years. It is expected that one director will be elected by the membership at large and one director will be elected by divisional representatives to the National Policy Congress to hold office until the Annual General Meeting of the Association in 2001. It is expected that the director elected by institutional members will hold office until the Annual General Meeting in 2002.

Nominations must be in writing and must be signed by two financial members of the Association and include the consent in writing of the nominee. Nomination forms must be accompanied by a 100-word current *curriculum vitae* which provides full details of academic and professional qualifications and a 100-word statement of professional concerns. The curriculum vitae should be arranged under headings of present positions, previous positions and professional activities. A standard colour portrait photograph must be included. Nomination forms are available from ALIA National Office, or via ALIANet.
