Access to Learning Award

n annual award of up to US\$1 million is given by the Gates Foundation to a public library or similar organisation outside the USA for an innovative program offering free public access to information technology.

The 2005 Access to Learning Award was won by Shidhulai Swanirvar Sangstha, a non-government organisation in Bangladesh, for its pioneering approach to bridging the digital divide and its commitment to providing free public access to computers and the internet. The organisation has converted indigenous boats into mobile libraries, which anchor at remote villages, using generators/solar energy to power mobile phones for internet access. The award was announced at the IFLA (International Federation of Library Associations and Institutions) conference in Oslo.

The Access to Learning Award is given annually to recognise the innovative efforts of libraries, organisations or library agencies outside the United States in providing free public access to information technology. o, Follows and Leeds — what's the story, Morning Glory? Where did you get the idea? Well to answer that question, here's the Evolution of an Idea to explain it all.

Once upon a time, in a galaxy far, far away, it was a dark and stormy night... hang on, that sounds a bit too familiar! It all began because my wife enjoys watching all those *CSI*, *Cold Case* types of TV programs. With the rise of these *CSI*-style programs, forensics courses at universities had become very popular, and I thought if only they did something similar for libraries then maybe librarianship courses would have a similar sort of rise in popularity. So I thought a *Cold Book Case* program would be it, where book detectives would go hunting for long-lost overdue books from libraries.

In planning the neXt 2005 Conference, the program committee asked for abstracts, but back in December 2004 they didn't know who was going to be submitting and were thinking of contingency plans should they not get enough. So, intending it to be an amusing joke for the Programming Committee, I wrote a one page — well, half-page — synopsis of a fictional TV program that I had supposedly sold to the BBC, in which these two book detectives would go around the UK finding long lost books and returning them to their libraries. I was going to

submit it anonymously pretending that an LT had written the series and the BBC had taken it up. I figured if I was going to tell a story I might as well make it a big story! As I said, it was supposed to be a sort of lighthearted moment for them as they were sorting through the submissions. In the end I didn't send it and they had plenty of submissions anyway.

After they had started sorting through the submissions we had another meeting and I thought I'd send it along as a 'what I was going to do but didn't' thing: I guess to see what other people thought of the idea. Trouble was, they all thought it brilliant and that we should incorporate it into the conference. We talked about how we could do this, or rather, how I was going to do this! In the end we decided that a sort of treasure hunt through the exhibitors would be a good way to encourage delegates to get involved with the trade. I said that if that was to happen then there needed to be some sort of reason why people would do it. There needed to be a story, a reason for the treasure hunt.

So on the way home from the meeting — the meetings were in Sydney and I had to get home to Wollongong — I 'composed' the basic back-story for the game. I wrote it out and fine-tuned it and it became the story delegates read in their satchels and the game they played while at the conference.
