AustLII free legal database in crisis

One of the most popular legal research databases used by Australian libraries is suffering a funding crisis, has slashed its staff, and is becoming out of date.

Since 1995, the Australasian Legal Information Institute (AustLII), has provided free and timely online legal information, but development grants from one of its primary funding sources, the Australian Research Council (ARC), have ceased, and the service is now calling for its major users to provide financial support.

AustLII has reportedly reduced its staff by one-third, resulting in databases not being updated as regularly as specified by the service's own guidelines, and 20 new databases failing to go online at all because of lack of funds. Apart from the ARC, AustLII receives significant funds from universities, government departments, private companies and law firms, but the service has made pleas to stakeholders for long-term operating funding.

An independent internet rating agency states AustLII has been receiving an average of 637,000 hits per day — three times the combined hits on all commercial legal databases — but, under its establishment model, because the service gets its content free from the government, it cannot charge users, nor can it carry advertising.

In the face of the loss of free comprehensive legal information to libraries, community legal centres and ordinary Australians, barristers, individuals and associations have been making donations to sustain the service. The NSW Young Lawyers group is even holding a fundraising barbecue.
