The following training courses are offered: Grants and Fundraising; Boards, Governance Leadership; Finance, Insurance and Risk Management; People Management; Strategic Planning, Review and Revitalisation; Information Technology; Community Engagement and

Volunteering Australia: the National Volunteer Skills Centre is a project funded by the Commonwealth Department of Families, Community Services and Indigenous Affairs and managed by Volunteering Australia. As part of this, Volunteering Australia has developed a number of resources and provides a range of services, including nationally recognised qualifications. It has three new accredited qualifications for managers of volunteers. Volunteering Australia is currently finalising a licensing policy for registered training organisation to deliver the courses. Some courses available include Diploma of Fundraising Management; Certificates I, II and III in Active Volunteering are nationally recognised qualifications, and there are online fora and short courses such as a one-day Occupational Health and Safety for Volunteers course.
