Last year the Board regarded this revision of the manual as a priority for the success of ALIA conferences and events, and the Conferences Standing Committee has been working on the revisions, together with ALIA National Office staff who have devoted a great deal of time to the project. Late in 2007, a draft of the new manual was circulated to convenors of upcoming and recent conferences. A very lively teleconference was held in October, in which members commented on various aspects of the revision, and were invited to send their thoughts. Following the teleconference, 11 substantial submissions were received; the feedback from these is now incorporated into the revision and the new draft will be circulated in February, with the aim of the manual being endorsed at the March meeting of the Board. Thanks go to Jane Hardy and Kamara Schlegel for all their time and energy, to the Standing Committee members and to the convenors and members for their comments and responses.
