Can you remember your first experience in a school library? For a lot of people, the teacher librarian is their first ever contact with the world of information, their introduction to the wonders contained within books and online resources, and where they take their first steps towards information literacy.

Therefore, it's actually hard to over-estimate the critical community role teacher librarians play. These are the professionals who, quite literally, take Australian children by the hand and lead them towards opportunities for a fulfilled and happy life.

Over the years, ALIA and the Australian School Libraries Association (ASLA) have worked together on various projects to raise the profile of teacher librarians and both organisations constantly seek to have input into the national debate and national policy development concerning information literacy. Within ALIA, the ALIA Schools Group works towards promoting the interests of school libraries and teacher librarians and supports members in professional development and advocacy. We also have ALIA representatives on the ALIA/ASLA Policy Advisory Group. With the trends revealed in recent research reports, there are many causes for concern about the pressures on teacher librarians and therefore on their continuing ability to develop information literacy among young Australians. In this world of dual (and more) qualified professionals, teacher librarians remain an unusual breed, combining qualifications in education and librarianship and working under expectations that they will participate both in teaching and in the library in the school environment. As such they, and others of us as their colleagues, all need to do what we can to make sure the general community understand the importance of information literacy and how teacher librarians deliver those skills within our schools. Those of us who are parents have an even more powerful incentive to get involved and add our support.

The ALIA/ASLA Policy Advisory Group meets regularly to discuss issues and projects. There is currently an ALIA representative vacancy on the group and calls for expressions of interest will go out shortly. New Terms of Reference for this group have also recently been agreed to, and these revised TOR's and the Memorandum of Understanding between ALIA and ASLA will be re-signed in October by Presidents, Jan Richards and Rob Moore at the ASLA Conference in Perth.
