The ALIA group, Health Libraries Australia (HLA), will be formally launching the Health Specialisation at their Professional Development Day, Friday 19 July 2013 in Adelaide.

Between 2009 and 2011, the HLA undertook a research project to determine the future skills and competencies required of health library and information professionals in Australia, and to develop a structured, modular education framework to meet those requirements. This resulted in the final report on the project – Health Librarianship Workforce and Education: Research to Plan the Future. ALIA has adopted the American Medical Library Association (MLA) Professional Competencies for Health Sciences Librarians and thanks the MLA for providing permission for their re-use.

The ALIA Board of Directors implementation of the report's recommendation has led to the Health specialisation being the first specialisation offered by ALIA. Other LIS areas of expertise are invited to put forward proposals for creating their specialisation
