## PRESIDENT AND VICE-PRESIDENT

ALIA is pleased to announce that two candidates have been declared elected as the next President and Vice-President of ALIA. Following the ALIA Annual General meeting on 21 May 2014, Damian Lodge will assume the role of President for a term of one year and John Shipp will become Vice-President (President elect).

Damian is a current Board member, and stepped into the role of interim Vice-President late in 2013. Currently a lecturer in Information Studies at Charles Sturt University, his previous roles include Director for the Centre for Information Studies and Manager, Client and Information Services for Charles Sturt University Libraries. He also serves on the ALIA Professional Development, Education, Research and Publishing Committee.

Damian is keen for his term as President to underpin leading ALIA into a bright future for both the organisation and the profession.

Incoming Vice-President John Shipp returns to the ALIA Board having previously served as President in 1998 and has also served as a board member and President of the Council of Australian University Librarians. He is currently pro bono Manager of the Illawarra Museum, having retired from his previous position as University of Sydney Librarian and roles with the University of Wollongong and Charles Sturt University Libraries.

John will bring his extensive experience in the education sector and in roles such as Chair, Public Lending Right to the Board and intends to include in his priorities a focus on ensuring that information professionals have access to appropriate career education and are recognised for their contribution to the well-being of our society.

#### THE CANDIDATES

**BEATRIZ AROCHE** 



With over 20 years library experience in the VET sector, I am concerned about the challenges faced by the library sector which has been neglected in political discourse and although sizable in terms of its workforce, is underrepresented at a professional level. My main concerns are the survival

of libraries and information professionals in a challenging budgetary environment, strategic management and business sustainability, skilling the profession, and ensuring libraries remain at the heart of our national culture through sustained lobbying. Increased collaboration between all library sectors is vital to ensure a strong professional association to give voice to these concerns.

#### **ELKE DAWSON**



ALIA has been very proactive during my last term as Director in the areas of advocacy, the Future of the Profession, engagement with ebook policies and the new Professional Development (PD) scheme initiative. I am seeking re-election as a Director in order to continue work on these initiatives

as well as following through on several others in the pipeline, which include defining the 'I' in ALIA, the development of ALIA's research agenda and its own digital repository to capture, preserve and promote its extensive portfolio of advocacy documents, research publications and conference papers to promote libraries, librarians and LIS research.

Our profession is re-defining what it means to be a librarian in a world of mobile devices, mass digitisation and complex copyright law that is shifting to ebooks. Expectations are high, yet most libraries face significant budgetary constraints. We need a strong, united and vibrant

professional association to advocate for fair use of copyright material in a digital world, access to ebooks through libraries, cost-effective library course accreditation, and recognition of ongoing learning through the PD scheme. If re-elected, I will continue to promote both the 'library' and 'information' skills of members and advocate on the issues that matter.
